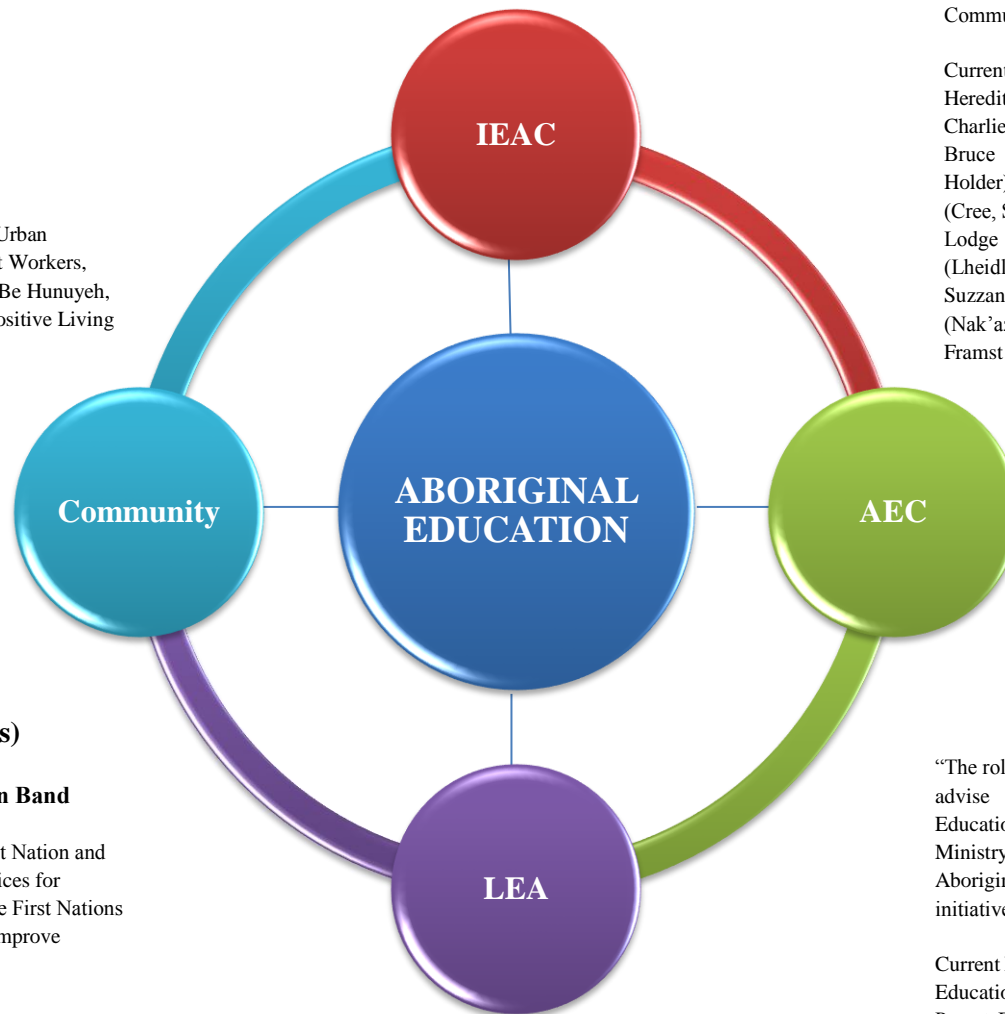


Aboriginal Community

“The role of the Aboriginal Education Committee is to support and advise the Aboriginal Education Department on Aboriginal Education Programs and Services as per the mandate from the Ministry of Education on Aboriginal Education and to involve the Aboriginal community where possible in Aboriginal Education initiatives that support Aboriginal Students”.
